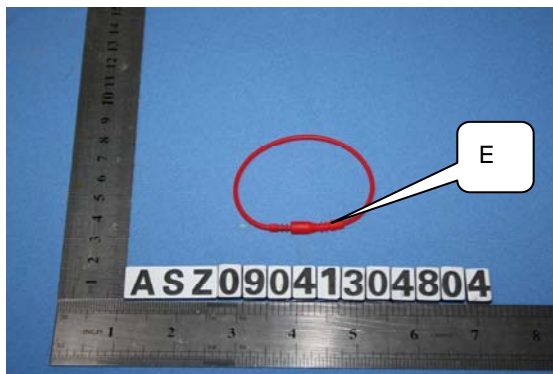
METAL SURFACE COATING / METAL INNER MATERIAL



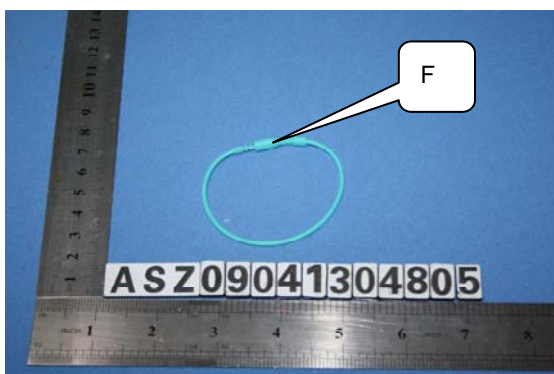
FUCHSIA SILKIES



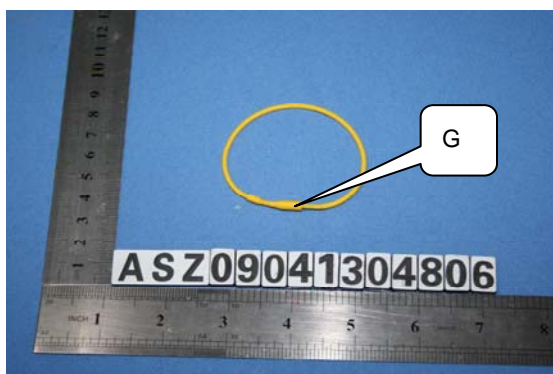
BLUE SILKIES



RED SILKIES



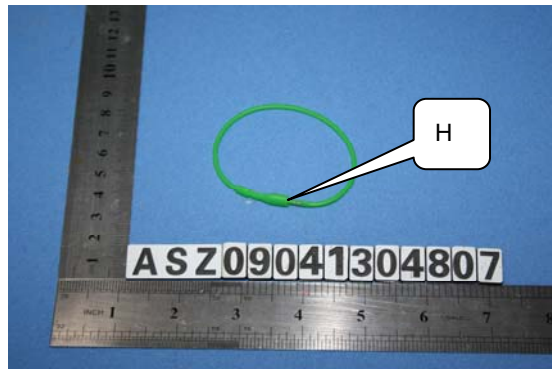
